- **3**. A resident complained that the posters presented at the July 10th BOS meeting on water quality testing were not being made publicly available. These are allegedly the property of CMA Engineers, Selectman Musselman's firm, and were apparently retained by his firm, allegedly placing them beyond the reach of the right-to-know law. More Detail
- **4.** The Town will proceed with an RFP for solar panel installation, even though many candidate sites are in the Historic District, where solar panels visible from the street are prohibited. More Detail
- **5.** Mike Cotreau has been appointed as the new Fire Chief without any public input or discussion. He is currently Fire Chief in Concord, Massachusetts. More Detail
- **6**. Rye Water District Commissioner Art Ditto was appointed as the Rye representative to the Seacoast Drinking Water Commission formed by new State legislation. State Representative Mindi Messmer had also sought appointment. More Detail

- 4. Selectman Musselman reported that, in the 1970s, trash was deposited up to 13 feet below the ground water level at the Grove Road Landfill. A recent test showing PFC levels of twice the maximum drinking water standard resulted in a visit by a DES engineer within two business days. The landfill is only about 1000 feet from the Garland Well, which supplies 60 percent of Rye Water District water. More Detail

Selectman Musselman, whose firm, CMA Engineers, has been doing the sample gathering and analysis at the Breakfast Hill and Grove Road Landfills, declined to release information in the CMA files relating to work paid for by Rye taxpayers, asserting that summary level information provided to the town was all that was relevant. This continues to get more complex. Here is a brief summary.

- 1. Coakley Landfill is leaching PFCs into ground water, Little River and Berry's Brook through surface run-off. Coakley Landfill Group has been compelled by EPA to put up warning signs about levels of PFCs in 4 locations adjacent to Coakley Landfill PFCs in monitoring wells around the Coakley Landfill increased, some as much as almost doubled, over last year. CLG will monitor PFC levels in 19 private wells in North Hampton and Greenland in 2017 and 2018. NHDES confirmed that they will sample two private wells in Greenland in the September. Rye will be compelled to sample private wells in Rye for PFCs.
- **2.** Rye's Breakfast Hill Landfill received incinerator ash and this also leaches into Berry's Brook. PFCs were detected in monitoring wells around the landfill.
- 3. Rye's Grove Road landfill has recently been tested for PFOA and PFOS and has had readings twice the state minimum.
- 4. Aquarion's well 5A has no aquifer protections
- 5. Rye Water District and Aquarion are both looking at adding wells
