1. Rockingham County indicates a projected tax rate increase of 1.9 percent. There was discussion of consolidation with the Fire Department and whether that would necessitate going away from County dispatching for Fire. [More detail](#).
2. The mosquito control contract was awarded to Swamp, the low bidder. No marsh restoration will occur without the concurrence of the Conservation Commission. [More Detail](#)
3. The Town Hall construction contract was awarded to Hutter for \$3,389,600, contingent upon voter approval. [More Detail](#)
4. Complaint about high Comcast rates may lead to formation of a Committee, but there appears to be little that can be done. Contract is up for renewal in January 2016. [More Detail](#)
5. A legal opinion relating to certain petitioned warrant articles will not be released as it is "evolving," based on discussions with the Town Attorney after he apparently issued an initial written opinion. [More Detail](#)

1. A hearing was held on the Heisey lot unmerger request involving two parcels on Harbor Rd. No decision was reached. The discussion focused on whether or not the lots had separate septic systems. [More Detail](#)
2. The final report on the Beach Parking Study was presented. Discussion focused on whether the loss of 140 parking spaces was accurate, and whether there were only about 7 driveways needing parking restrictions. [More Detail](#)

### **January 14th - Budget Committee School Board Hearing:**

1. Agreement has been reached with the teachers union. Improvements on health care costs, but wages went up 2.4 to 3.5 percent. [More Detail](#)
2. A \$10,000 warrant article to provide funds for a deposit on land behind the Junior High School was approved unanimously. The plan is to finance the acquisition entirely with donations and another 1.5 acres will be donated. [More Detail](#)
3. A \$3000 petitioned warrant article to provide video streaming of School Board and other meetings at the Junior High was rejected 7-1 even after data on the actual \$1200 and \$800 costs of installing similar systems at the Library and Town Hall was deemed inconclusive to the likely cost at the Junior High School. 4. Several Budget Committee members asserted that the budgeted \$3.44 per gallon heating oil price and projected usage 30 percent above the 2010-2013 average needed no adjustment notwithstanding the current price of around \$2.50 per gallon and a customary price lock in July of this year. 5. Budget Committee member Doug Abrams left after a resident asserted that the Budget Committee had achieved only \$500 in reductions and never listens to the public. He is up for re-election. [More Detail](#)

1. Increase to Town Clerk/Tax Collector budget for third full-time employee was unanimously recommended. [More Detail](#)

1. \$568,911 more will be needed to be raised through property taxes. \$206,089 (budget increase) + \$241,322 (reduced surplus carry forward) + \$92,500 (fewer RJH New Castle students) + \$29,000 (reduced Medicaid reimbursement)
2. 5th Grade position will be eliminated. The current two non-budgeted Special Education positions, plus two additional Special Education

positions are being added. Special Ed budget is 9.29% of the total school budget.

3. PHS per student tuition is estimated to increase again. Two year increase of 11%.
4. Rye funds 48.34% of the SAU50 budget
5. Maintenance Fund will be getting \$5,000 less than normal.
6. Budget numbers do not include the current teachers union contract under discussion, that is separate warrant article.

1. The CIP Committee has completed the 2015-2020 plan. It includes "Total Capital Costs" of \$16.499 million over the period, of which:

\$ .57 million is Category 1 (to secure life and property)

\$ 7.464 million is Category 2 (to maintain the present standard of living)

\$ 8.465 million is Category 3 (to improve the community)

2. The CIP expenditure for 2015 is planned to be \$1.609 million, excluding Town Hall, which would be bonded for \$3.8 million in that year so is not included in the total. Major projects are:

- Town Hall (2015): \$3.800 million

- Recreation Community Center (2016): \$2.475 million

- Additional Conservation Bond (2017): \$3.000 million

- Fresh Water Treatment Plant (2018): \$5.500 million

### **Climate Change Workshops:**

These have been completed and there was a presentation to the BOS, but actions have yet been committed to. Residents need to continue to insist the town updates the Master Plan and the town boards act accordingly.
