Selectman Mills, who had not been to a meeting in many months, was conferenced in by telephone for the vote on the Public Works Employee contract as Selectman Jenness recused herself inasmuch as her son works at the Transfer Station. More Detail
- 2. The Selectmen voted in favor of placing their \$3.4 million warrant article to tear down and rebuild Town Hall, but voted not to recommend the \$3.2 million Heritage Commission article to renovate the building. Selectman Musselman complained that the Heritage Commission's action ensured that neither article would pass. More Detail
- 3. The Selectman voted not to recommend a \$500,000 petitioned warrant article to perform several repairs to Town Hall. Selectman Musselman asserted that it was not enough money and said that if the article passes and the Board of Selectmen agree they would not have to do anything. More Detail

Selectman Musselman explained the purpose of the meeting, which was to take public input on which of two options for Town Hall (tear down and rebuild a replica, or renovate), should be chosen, or whether neither should be. Soft costs have been estimated at \$300,000, so the cost of the replica is \$3.4 million, and of the renovation, \$3.2 million. More Detail
- 2. Many members of the public spoke. More seemed to be in favor of a new building, but few, if any, thought that a replica was an appropriate choice. More Detail
- 3. A straw poll was conducted. Two favored renovation, twelve favored tear down and rebuild of a replica, and twelve favored neither. More Detail

- **1.** The Budget Committee voted 6-3 not to recommend the Selectmen's \$3.4 million warrant article to tear down and rebuild Town Hall.
- 2. The Budget Committee voted 7-1 not to recommend two petitioned warrant articles to deal with Town Hall. The first was a \$3.2 million warrant article submitted by the Heritage Commission to renovate Town Hall. The second was a \$500,000 warrant article to repair and refurbish Town Hall and provide handicapped access.
- **3.** The Budget Committee voted 7-1 to recommend three collective bargaining agreements. The member voting against cited the 2.5 percent increase at a time when Social Security recipients are receiving only .3 percent increases.

- 1. The increase in Special Education costs from about \$1 million in 2013 to over \$1.7 million in the 2017-2018 budget was questioned, particularly in light of the constant cutting of the Elementary School and Junior High budgets (excluding Special Education) in order to keep the budget flat as teacher salaries increase.
- **2.** The calculation of the default budget, which is supposed to be based on the prior year's budget, was questioned. It is only \$120,000 less than the proposed operating budget, which is up approximately \$650,000 over the 2016-2017 budget.
- **3.** There was significant discussion of a petitioned warrant article to form a committee to study combining the two schools.

- **1.** The Budget Committee addressed the \$80,000 warrant article to advance the Recreation Community Center and voted 7-1 to recommend it. Peggy Balboni voted against, citing the unused space at Rye Junior High and the need for an overall plan.
- **2.** The Collective Bargaining Agreement increases are much higher than three years ago because of stipends to employees who choose lower cost health care plans. The town will

actually save much more than the cost of the stipends, according to Town Administrator Magnant.

**3.** There was more discussion of the three Town Hall warrant articles with appropriations attached. One of the signatories of the \$500,000 warrant article to repair and refurbish Town Hall described how the Town Hall process had gotten off track, and that this was the only warrant article with a chance of passing this year, given the survey responses indicating a maximum supported cost of \$2 million and that over 60 percent do not want to tear down the Town Hall.

The CIP Committee recommendations are based upon a scale of priorities. Priority One is to secure life and property. Priority Two is to maintain the present standard of living. Priority Three is to improve the community consistent with the Rye Master Plan. The Recommendations made in this CIP are:

- 1. The CIP Committee agrees school security is the number 1 priority.
- **2.**The CIP Committee recommends the replacement of the Public Works Dump Truck #108. It is in poor condition.
- 3. The Town Hall redesign reflects a revised placeholder of \$2.9MM in 2018.
- **4.**To fund a new Quint Fire Truck in 2018 the CIP recommends a warrant article to add to the Fire Truck Capital Reserve Fund. A new Quint Fire Truck estimated at \$575K.
- **5.** The CIP Committee recommends the delay of the Conservation Bond \$3MM and the Recreation Community Center Building at \$2.5MM pending the Town Hall design decision. The CIP was accepted by the Board of Selectmen at their meeting on November 28, 2016.
