- **1.** Summer Sessions beach permit tabled for two weeks after e-mail from resident expresses concern about possible activities last year beyond the scope of the permit. More Detail
- **2.** Public Safety Building Energy audit reveals shortcomings in the construction and configuration leading to energy waste. More Detail
- **3.** Winter-related costs will be \$45,000 to \$60,000 above budget. It appears that, rather than reducing the paving budget to compensate, other surplus areas will be reallocated to address the shortfall, rather than returned to taxpayers as in past years. More Detail
- **4.** Recycling Center sticker implementation is proceeding. These will be free to Rye residents, but may be offered to North Hampton residents for a fee. More Detail
- **5.** The Selectmen question whether filling a Fire Department position is needed as it would place a third person on one of four shifts. Further study is needed. More Detail

- **1.** Police Chief Walsh presented a detailed analysis of parking along Route 1A indicating that there are 51 driveways that may need to be "boxed." A final decision will be made after a site walk. More Detail.
- **2.** The 2015 budget is insufficient to stripe parking spaces along Route 1A. More Detail.
- **3.** Selectman Musselman contradicted his statement on April 29, 2014 that the ball was in the Town's court with regard to parking meters. He now says that, since no money was budgeted in 2015 for a parking study, the earliest that meters could be installed is 2017. He argues that that would depend on an agreement with the State, notwithstanding his earlier statement, a specific inquiry by Senator Stiles and a State law specifically authorizing towns to install meters. More Detail.
- **4.** Specific Beach Committee recommendations regarding permit fees, mobile lifeguard stands and stand-up paddleboard issues failed to lead to firm commitments by the Selectmen for further action. More Detail.
- **5.** Projected lifeguard need for this summer is 13-17, however only six lifeguards from last year have expressed an interest in returning. The Head Lifeguard will not be returning. More Detail.

- 2. Scott Marion will chair this year with Mike Moody as the Vice Chair.
- **3**. The cracks in the RES walls were evaluated by a structural engineer and do not impact the structural integrity of the building
- 4. Kindergarten teacher Anne Barr is retiring.
- **5.** Resident requested that RES evaluate the STAR results of those 5th graders not planning on attending RJH vs. those planning on RJH.
- **6.** SAU 50 Curriculum Committee provided a formalized statement for the purpose for Math education, more information when the School Board meeting notes are posted.
- **7.** A 5th grade teacher is moving to 3rd Grade and 5th Grade will have 3 teachers with each dedicated to Math, Language Arts or Science. All three will teach Social Studies.
- **8**. There will be a new dress code for RJH next year and it will be documented in the handbook.
- 9. 2015/2016 School Calendar was approved, but it is not posted yet

- 1. 23 Spring Road: Second Driveway request approved all in favor
- **2.** 464 Bracket Road Subdivision: Approved all in favor with list of 20 conditions of approval
- **3.** 561 South Rd (Rye Farm): Site development approved all in favor with 21 conditions of approval. The Conditional Use permit with 16 points was also approved all in favor. Click Here to see all of the conditions as listed on the town meeting minutes.
- 4. Summary of 561 South Rd Development
- **a)** Originally proposed as 5 residential lots (including one with the original house), with the largest lot (lot 5) discussed as a Retirement Community Development.
- **b)** Water management complexities as the property is in the Aquifer and Wellhead protection district and public concerns helped lead to a hydro geologic review.
- c) In addition to accommodations made to the direct abutters (of South Rd), the builder reduced the project to 3 new lots (down from four) with Lot 5 sold to the town of Rye. The appraised value is \$440,000 with the Conservation Commission currently working to find other funds and grants for the \$350,000 purchase price, before utilizing the current Conservation Land Fund (\$3M less the \$1.25M used for the land behind the former Rand Lumber Condo Development).

d) 580 South Road, the house that is T-boned by the new street is having the mailbox moved as the only accommodation.
