- 1. Local builder, Town resident and 2011 Town Hall Space Needs Committee member Joe Tucker presented his case for demolishing the existing Town Hall and building a single replacement building, arguing that the cost would be lower. More Detail
- 2. Town resident Del Record questions whether or not the Committee was in fact charged with preserving the Town Hall. More Detail
- 3. Town Hall Committee member Mae Bradshaw questions whether the townspeople would ever permit demolition. <u>More Detail</u>
- 4. Joe Tucker points out the past lack of accountability for cost overruns. More Detail
- 5. Architect Jason LaCombe of SMP disputes that the structural problems were identified at the eleventh hour. More detail

- 1. The architect states that, due to the extent of change to the Town Hall, the most stringent building code applies, and the building must be brought up to code. The building is deficient in part because the building appears to have been extended upward at some point by placing new walls underneath it, such that the heavy timber posts no longer extend to the foundation. More Detail
- 2. The structural engineers describe two solutions. The first, exposed angle braces on the interior, would cost approximately \$67,000. The second, hidden steel posts in the walls that would extend to the foundation, would cost approximately \$144,000. More Detail
- 3. Four members of the Town Hall Committee select the second option. More Detail
- 4. An unbudgeted emergency generator may also be required to prevent catastrophic freezing in the event of a power outage. More Detail

1. 243 Central Road (3:38)

Major Site development passed with 9 conditions (page 4/5 of meeting minutes). There are many variances granted that allows for this project to move forward Click Here for video time stamps of the discussion

2. 561 South Rd (Rye Farm) (53:00)

Major Subdivision and Conditional Use Permit. Sub-dividing into 5 lots and building a 590ft new town road. Planning Board accepted Jurisdiction to proceed, which means the project is moving forward, Site walk, further development....

- a) Board would not let the public discuss if the builder will at some point request Lot 5 to support a Retirement Community Development (RCD)
- b) Much concern about drainage, water run-off, wetlands, the feasibility of using "logging roads" for construction equipment
- **3. Rules of Procedure** (2:20:40). In 2012 the Planning Board replaced the 2009 rules of procedures with older 1998 Rules of Procedure without documented discussion or public notice. No documentation is provided to show all members and the public were aware of the changes as the negated 2009 Rules were what were available for the public until July of 2014.

Rules and Regulations: September 24th:

- 1. Aquifer Protection section (306) of the zoning ordinance discussed with Danna Truslow who was invited to comment due to her expertise. Extended discussion of septic system issues. Suggested ordinance includes reduced limit for impervious coverage which may be exceeded with a special exception or storm water management plan.
- 2. Strengthened impervious coverage definition is proposed, with options of using the definition in State law or a more detailed set of criteria from a town in Maine. Ordinance use of "impermeable" in places will be amended to "impervious."
- **3.** Rules of Procedure have been reviewed by Chairman Keriann Roman and will be brought up at the October and November Planning Board meetings for adoption. Town Attorney has expressed an, as yet undisclosed, opinion that the Rules were validly amended in 2012.

1. The CIP Committee has completed the 2015-2020 plan. It includes "Total Capital Costs" of \$16.499 million over the period, of which: \$.57 million is Priority 1 (to secure life and property)

\$7.464 million is Priority 2 (to maintain the present standard of living) \$8.465 million is Priority 3 (to improve the community)

- **2.** The CIP expenditure for 2015 is planned to be \$1.609 million, excluding Town Hall, which would be bonded for \$3.8 million in that year so is not included in the total. Major projects are:
- Town Hall (2015): \$3.800 million
- Recreation Community Center (2016): \$2.475 million
- Additional Conservation Bond (2017): \$3.000 million (in addition to -
- \$3 million bond approved by voters in 2014)
 - -Fresh Water Treatment Plant (2018): \$5.500 million

Climate Change Workshops:

These have been completed and there was a presentation to the BOS, but no definitive actions have yet been to be committed to. Residents need to continue to insist the town updates and the Master Plan and acts accordingly.

As of December 2013 the town has **\$3,389,508** in Trust Funds, Capital Reserves. <u>Click Here</u> for the town document.

- **1.** The School District reported a cumulative surplus of approximately \$411,000 at the end of the latest fiscal year in June. Most of this is being retained to avoid the appearance of a spike in the 2015-2016 tax rate. This year's tax rate should be flat, nevertheless. More Detail
- **2.** High School tuition was well under the budget due to fewer students than anticipated, saving approximately \$194,000. More Detail
- **3**. However attendance is dropping, raising per student costs, a particular concern at the Junior High School. More Detail
- **4.** Town expenditures appear to be on budget, with 58 percent of the budget remaining after the first half. Revenues are up \$116,000 over the prior year. More Detail
- **5**. Budget Committee Chairman Paul Goldman discusses his recent assumption of the Chairmanship of the Town Hall Committee. He praises the architect, but complains that they have had to endure wide-ranging discussion in the process of closing in on a plan. More Detail
