- 1. The Recreation Department's move to a modular unit at the Rec Facility was discussed, and the Committee felt that this had no bearing on the square feet of the new Town Hall complex.
- 2. SMP Architect, Jason LaCombe, informed the Committee that to bring the existing Town Hall to current code the existing 8 side wall beams would have to be reinforced with steel supports. This will significantly increase the price of the project. Previous engineering reports apparently ignored the side walls.
- **3**. SMP will be obtaining construction bids and expects to have information for bidders by Thanksgiving.

- **1.** The School District reported a cumulative surplus of approximately \$411,000 at the end of the latest fiscal year in June. Most of this is being retained to avoid the appearance of a spike in the 2015-2016 tax rate. This year's tax rate should be flat, nevertheless. More Detail
- **2.** High School tuition was well under the budget due to fewer students than anticipated, saving approximately \$194,000. More Detail
- **3**. However attendance is dropping, raising per student costs, a particular concern at the Junior High School. <u>More Detail</u>
- **4.** Town expenditures appear to be on budget, with 58 percent of the budget remaining after the first half. Revenues are up \$116,000 over the prior year. More Detail
- **5**. Budget Committee Chairman Paul Goldman discusses his recent assumption of the Chairmanship of the Town Hall Committee. He praises the architect, but complains that they have had to endure wide-ranging discussion in the process of closing in on a plan. More Detail
