- **1.** Jim Katkin gave an update on the Unassigned Fund Balance. There is a much larger amount this year due to lower health insurance rates than predicted. He also presented the water testing results. These results will be handed off to Mindi Messmer for result interpretation.
- 2. Amy Ransom, the assistant business administrator presented a budget timeline. She is planning on attending the all day budget session and meetings with the budget committee. Special Ed director Sarah Reinhardt made her report. Special Education discussion to happen with Portsmouth on September 26th will all SAU 50 & Portsmouth School District.
- 3. The new math curriculum was adopted.
- **4**. The Rye PTA received an honorable mention from a national PTA organization for their outstanding after school enrichment programming.
- 5. The science curriculum will be reviewed, likely starting this Fall.
- **6.** SAU Assessment committee to look at the newly passed NH House Bill 166-students will take tests once in elementary, once in middle school & once in HS. NH is asking for a waiver from ESSA (supersedes any state bill) which requires students to take a test once a year in grades 3-8. Until the waiver is granted, we still need to comply with testing (Smarter Balance).

- **8**. Project Based Learning Consultant worked with both RES & RJH before school started. Positive response from staff.

- 1. Anecdotal data from two realtors reveals that only thirty percent of Rye properties are being sold to families with children. More Detail
- 2. Rye Junior High School enrollment, as of the start of the 2017-2018 school year is 134, 12 fewer than projected in the budget. The sixth grade class is 45 students, compared to 60 in the 2016-2017 fifth grade. The decline is attributed to private school attendance and families moving out of town. All space is currently utilized, according to the Principal. More Detail
- 3. Rye Elementary School attendance, as of the start of the 2017-2018 school year is 275, 13 more than projected in the budget, largely due to a Kindergarten enrollment of 50 vs. 38 projected using live birth data from five years earlier. All space is currently utilized, according to the Principal. More Detail
- **4.** The total enrollment of 409 is only nine more students than the stated Rye Elementary School capacity, raising the importance of accurate enrollment projections in considering the school consolidation option, according to one resident. More Detail
