- 1. Consideration of the Library budget was tabled for the third time, pending further investigation of the figures by the Library Director and the Town Finance Director, thus wasting the time of three Library Trustees who were present, as well as the Library Director, all of whom had come to discuss the budget. More Detail
- 2. The \$60,000 budget for document scanning in 2017 will not be spent, despite three bids in that range, because the government document scanning market is believed to be insufficiently developed. More Detail
- **3**. Randy Crapo has not attended a CIP Committee meeting in three years. The town will write him a letter asking for his resignation and outlining the next steps to remove him if he does not resign. More Detail
- **4**. The TD Bank building acquisition for \$540,000 is proceeding towards presentation at 2018 Town Meeting. More Detail

1. The Wentworth-by-the-Sea Country Club has blocked reinstallation of the "Sanders Poynt, 1623" sign and DOT has refused to allow it to be installed in the State right-of-way. The Town Administrator will appeal to the DOT Commissioner. More Detail

- **2**. The CIP Committee presented its plan for \$2.752 million in projects in 2018, however some project costs include only the initial principal and interest payments. The true capital cost for just eight major projects totals over \$5.8 million in 2018. More Detail
- **3**. An engineering contract was awarded for the Shoals View Dr. paving. The estimated cost is now \$250,000. The project will proceed in either 2018 or 2019. More Detail
- 4. Beach parking sticker prices are being raised from \$20 to \$25. More Detail
- **5**. The Selectmen rejected, for now, the hiring of a "Jack-of-all-trades" by Public Works at a cost, with benefits, of approximately \$72,000 annually. More Detail
- **6**. The Library budget was tabled after a contentious discussion with the Library Trustees. Selectman Musselman incorrectly characterized recent wage studies to argue that the Library, but not the Town, employees are overpaid. Selectman Musselman also attempted to reduce the Library budget after the Library Trustees had left the meeting. More Detail
- 7. The 2018 Conservation budget of \$90,000 was approved notwithstanding only approximately \$8000 of the 2017 budget having been spent through September. A flurry of last-minute spending will use up most of the 2017 budget. More Detail
- **8.** Despite the overwhelming rejection of a town-wide vehicle by voters in 2010, the acquisition of such a vehicle as part of 2018 operating budget was approved. It will be used for the transportation of injured seagulls, among other things. More Detail
- **9**. Permission to display, at the Town Hall, information related to an upcoming petitioned warrant article to demolish and rebuild the building will not be given. The proponent will need to obtain his own legal advice to make his warrant article conform with legal requirements for bond issues. More Detail

- a) NH Bill 193 Title: establishing education freedom savings accounts for students. The NH Senate passed the House Education Committee Bill that has the potential impact on school funding. Still questions of whether this is allowed under the NH Constitutional Law; however, the new proposal for the Bill states the funds would be distributed through a scholarship clearinghouse before distribution. By funneling public money through a clearinghouse, the money could then be used at any religious school. It is unknown how it will impact Rye.
- **b)** Manifest Educational Hardship Act RSA 193:3-to be amended which takes away some of the local control or Superintendents and School Boards. Portsmouth Herald Editorial SB 193 <u>Click Here</u>:

- **3**. A public hearing on the new chapter "Coastal Hazards and Climate Adaptation" of the Master Plan is scheduled for the Planning Board December 12th Agenda Click Here
- **4.** The process of planning for and drafting the new chapter 3 "Coastal Hazards and Climate Adaptation" began in January 2016 with the assistance of Julie Labranche from the RPC. The initial plan was to complete the updates of the Master Plan, including drafting the new chapter (3) and updating three other chapters, by September 2016, given the deadline of a grant provided in the amount of \$8,500 (additional money \$ 11,500 for the updates was provided by the Town). All money has been spent.
- **5.** Extensive discussion regarding the process of updating the Rye Master Plan from the same core group of residents was heard at the October & November meetings, however, the "next steps" for the remaining three chapters will be simplified, i.e. no Visioning Session (via a survey) and no Implementation Plan, as was discussed/recommended at the October meeting by Julie Labranche from the RPC.
- **6**. Chair Bill Epperson is proposing to complete the update of the three remaining chapters (Natural Resources, Land Use, and Transportation) with the help/participation of the same core group of residents in the upcoming months by meeting at the Rye Library.

- 1. Two members are stepping down (different personal reasons), so there are two more open positions on the Recreation Commission.
- 2. Discussion about approaching the Rye School Board earlier in the year for After School Space needs.
- 3. BOS had tabled the \$150,000 budget request for the Storage facility.
- **4**. Rye Recreation projects are partially funded through program revenue. Examples are: \$50,000 for the new Rest Rooms will come from Recreation revenue, not taxes, Recreation is funding \$10K for the Area Site Plan and funded \$15,000 of the Guard Rail/Fence project and \$20,000 field drainage work.
- **5**. Storage Facility will also be a concession stand and maintenance facility, so it will be reffered to as the multi-purpose service facility.
- **6.** Local Government Center informed the Recreation Commission that BOS approval is not required for Revolving Fund expenditures and the Budget Committee has no authority over the fund.
- 7. Member Mikolaities sent a letter to the BOS about the Town's responsibility for funding a means for proper and timely winter maintenance at Rye Recreation.
- **8.** There are 71 participants in the K-5 Recreational Basketball program. RES also has a 5th Grade Team playing in the Portsmouth Recreation League (Rye and Greenland 5th Grades have been participating for many years).

- 1. Route 1A Force Main Project Plan was presented. Waste water will be trucked to a Hampton manhole.
- **2**. There have been seven (7) applications for secondary water meters. These are used for lawn irrigation as this water does not go into the sewer system.
- **3.** NO word that Hampton notified Rye of termination, so the agreement should be renewed for another five years automatically, ending November 16, 2024.
- **4.** Hampton Sewer Treatment plant is in dire need of repairs and Rye is responsible for 4% of the Hampton capital investments. See Portsmouth Herald story <u>Click Here</u>

- 1. Shawn Crapo was seated and permitted to vote over the objection of one member who had provided a six page memorandum on why that would be unlawful. It argued that the statute requires village district representatives to the Budget Committee to be appointed by their respective boards, and that Mr. Crapo is not a commissioner and thus has no "respective board" that may lawfully appoint him. More Detail
- **2.** Most proposed expenditures were approved and the meeting ended at approximately 3:00 p.m. despite being planned to end at 4:30 p.m.
- **3.** There was one vote against \$24,000 for the purchase of a town-wide vehicle to be used, in part, for the transportation of injured seagulls. The member voting against noted the lack of economic analysis and conflicting information on the mileage of police cruisers when they are turned over for use by town departments. More Detail
- **4.** A member unsuccessfully sought to table most Capital Outlay requests so that they could be considered together with a possible \$5.8 million in warrant articles. More Detail
- **5.** The budget that would have added a "jack-of-all-trades" for Public Works was tabled pending further discussion between the department head and the Selectmen. More Detail
- **6.** Unlike during consideration of the 2017 budget, Shawn Crapo recused himself from voting on the Recreation budget after a member so requested. Mr. Crapo's company holds the contract for mowing at the Recreation Area. More Detail
- The Library budget was not considered as there is, as yet, no consideration by the Selectmen of it. More Detail
- **8**. There was one vote against, and one abstention, related to the Land Management budget because of reductions and/or insufficient funds to conduct water testing for PFCs and monitoring Parsons Creek for bacterial contamination. More Detail
- **9.** There was one vote against the Legal budget by a member who felt that the town was not well-served by the current town attorney. More Detail
- **10**. There were two votes against the Town Hall budget by members asserting that there were insufficient maintenance funds to properly maintain the building. <u>More Detail</u>
