- 1. The appropriateness of the Salt Shed and the Transfer Station being located 1800 ft. from the Town's main well and on highly transmissive soil was questioned. More Detail
- **2**. The priority for the Red Mill Ln. culvert was questioned in light of potential weight limits associated with the Harbor Rd. bridge which would not be removed for a number of years More Detail.
- **3**. The rationale of the proponents of the petitioned \$3.05 million warrant article to tear down and rebuild Town Hall was provided. More Detail
- **4**. Article 12 to purchase the former TD Bank was amended to remove any reference to specific uses, but would still allow some town offices to be moved there for an indefinite term. More Detail
- **5.** An amendment to constrain the price for which the Trolley Barn (Old Police Station) could be sold was defeated. <u>More Detail</u>
- **6**. Article 29, a petitioned article providing for visioning sessions (a Charrette) of the Town Center survived with some amendments and general support. More Detail
- 7. The \$9.2 million operating budget was placed on the ballot without amendment. Resident comments included noting the fact that the budget, after adjusting for reductions in capital outlay and debt service, was actually up over 2017, and describing the new tax environment now that only the first \$10,000 in state and local taxes may be deducted. More Detail
- **8.** Article 15, changing the purpose of the Fire Truck Capital Reserve to encompass ambulances was amended to remove a provision that would have enabled the Selectmen to spend money in that reserve without a town vote. More Detail
- **9**. Article 17, a new deck for the Harbor Rd. bridge was placed on the ballot without amendment. The bridge weight limit will not increase until 2025 or 2026 when a more extensive refurbishment is planned. Three of the Town's fire trucks have gross vehicle weight ratings exceeding the weight limit of the bridge. The Public Works Director said that overweight vehicles might damage it a little bit, but bridge collapses are rare. More Detail
- **10**. Article 28, to close Dow Ln., was amended to recommend that the Selectmen address the intersections at each end. More Detail
- **11**. Article 31, to rescind the Selectmen's authority to buy and sell land without a Town Meeting vote, was subject only to a clarifying amendment. More Detail
- **12**. The Town Attorney threatened to make a resident "answer for" allegedly accusing him of violating the Code of Professional Responsibility for attorneys by entering into an allegedly unlawful settlement agreement on the South Rd. litigation committing a Town Board and a Town Commission to take certain actions, notwithstanding the requirements of prior public hearings More Detail
- **13.** Article 33, which would have established a process to improve the timely posting of minutes in compliance with State law was amended to require only that State law be adhered to. More Detail
- **14.** Article 34, which would have required the leashing of dogs on Town land, was amended to require only that they be under control. More Detail

- 1. An attempt to decrease the operating budget by approximately \$76,000, the cost of Rye's contribution to the Robert J. Lister Academy in Portsmouth to which it has sent only one student in recent years, failed to pass. More Detail
- 2. An attempt to increase the operating budget by \$89,000 to provide pay increases to support staff, whose pay has been frozen due to the failure of union negotiations for the second year in a row, failed to pass. More Detail
- **3**. The proponent of a petitioned warrant article to move responsibility for approving the default budget from the School Board to the Budget Committee explained his rationale. Adjustments to the default budget for 2017-2018 were a major reason for the \$900,000 increase in school taxation over the prior year, he asserted. More Detail Click Here about NH court case.

- 1. A long-time resident provided documents to the Selectmen that, she said, supports her assertion that Esther Parsons had not wanted the TD Bank parcel put to a government use. More Detail
- **2.** Approval of the \$300,000 conservation acquisition associated with the South Rd. development settlement was tabled after a resident expressed concerns, including noncompliance with 2015 Article 27, which requires a hazardous waste study for land previously used commercially. More Detail
- **3**. The Rockingham Planning Commission presented the results of their study on Dow Ln. traffic. More Detail
- **4.** The owner of 56 acres of land adjacent to the Town Forest complained about the lack of effective action to control dogs and the fact that three members of the Conservation Commission are opposed the leash law. More Detail

Selectman Jenness' motion to support two New Hampshire House bills on Coakley Landfill remediation and a transparency requirement for the Coakley Landfill Group died for lack of a second after Selectman Musselman, admitting that he was a member of "the group," warned that the issue was none of Rye's business. - **6**. The Housing Partnership's proposal for the Parsonage Apartments, if any, will be presented in April. Rent increases of thirty percent appear likely. <u>More Detail</u>
- 7. The Fire Chief said that usage of PFC-containing firefighting foam in Rye has been minimal, however some may have been used on the Grove Road Landfill, which is near the Garland Well. More Detail

- **2.** Mr. Katkin (SAU Business Administrator) presented the Board with a list of capital improvement priorities for Rye schools. The board requested cost estimates on all items falling within the next 5 years.
- **3.** Ms. Killen (SAU 50 Asst. Superintendent) presented information on a proposed learing management system (LMS) called Schoology. The board expressed general concerns about the benefits of adoption of Schoology in Rye schools. Mr. Petralia (SAU 4. Superintendent) suggested a demo of Schoology at the March meeting.
- **4.** Mr. Petralia and Ms. Tsetsilas met with the principals to discuss potential next steps regarding school use. Most of the time was spent discussing RES becoming K-4 and RJH

- 1. A "Planning Board Master Plan Committee" was formed to finalize the updates of the three chapters: Transportation, Land Use, and Natural Resources. Great emphasis was made that this was only an update of the three chapters, not a rewrite. (Editor's notes: The initial plan was to complete the updates of the three chapters by September 2016 with the assistance of Julie Labranche from the Rockingham Planning Commission. A core group of residents provided extensive input and comments at the September, October, and November 2017 Planning Board meetings, resulting in the Planning Board coming to grasp that more work was needed prior to adopting the chapters).
- 2. The Committee met on February 23rd and reviewed page by page the Transportation chapter. Chair Pat Losik is hoping that the Committee will have completed its review of the updates of the three chapters by April.
- 3. The "revised" Transportation chapter dated October 11, 2017, is not available on the Planning Board webpage under "Draft Master Plan Chapters" (the Natural Resources is posted twice and there is no revised version of the Transportation chapter).
