- **1.** A Brackett Rd. resident complained that only 30% of a submitted list of questions went to Verizon. (1:32 elapsed).
- 2. Resident urged Select Board to have Fire Services Long Term Strategy that coordinates fire equipment across N. Hampton, New Castle and Greenland (mutual aid from Portsmouth and Hampton) prior to acting on the Fire Chief's 20 year equipment plan. (7:10 elapsed)
- **3**. Residents requested Select Board ban beach parking on one or more sides of Perkins Road for safety concerns. (13:53 elapsed)
- **4**.. The Library Trustees presented its compensation policy which provides pay for outstanding performance and provides for a survey, every two years, of other libraries in the state to ensure that pay scales are adjusted to be just above median levels (29:55 elapsed).
- **5.** Marty Chapman of The Housing Partnership presented his proposed one year extension to the Parsonage Apartment lease that includes a reduced rate, to provide time to relocate the residents(subtenants). The result would be an empty building and no revenues to the town after the end of the process (60:48 elapsed).
- **6.** A resident complained that plans to widen the shoulders of town roads to accommodate bicycles and pedestrians when the roads are repaved were started but then abandoned (75:43 elapsed).
- **7.** TD Bank will be sent a letter asking for the elimination of "holes" to ensure that the town's deposits are backed by collateral under a broader range of scenarios than is currently the case. Government insurance applies to only the first \$250,000. Resident Mike Coutu was thanked for his assistance and valuable expertise on the issue (94:38 elapsed).
- 8. Revenue enhancement strategies were discussed (103:33 elapsed).
- 9. The Selectmen will move forward with temporary "leash required" zones in the Town Forest at the request of the Conservation Commission and in accordance with pending Dogs-at-large Committee recommendations. The plan is that these will be replaced next year by a program whereby special town "tags" will be required for unleashed dogs in a number of areas (108:58 elapsed).

- 1. Rebecca Bergeron was introduced as the new Assistant Town Administrator/Finance Director, replacing Cyndi Gillespie who is retiring (9:17 elapsed)
- 2. The draft Historic Structures Report on Town Hall, presented by the Groundroot Preservation Group concluded that the building is a historic treasure and is structurally in really good condition, with mostly cosmetic issues such as the paint, glazing and clapboards. The Select Board agreed to look at getting some of the clapboards replaced prior to the already-contracted painting to occur this Fall (14:45 elapsed)
- **3.** Fire Chief Mark Cotreau presented his proposed 20 year capital plan for fire equipment which calls for maintaining three Class A pumpers, with a \$650,000 pumper/ladder scheduled as early as 2019. Discussion of how to educate the public prior to putting purchases on the ballot. (77:54 elapsed).
- **4.** The Harbor Rd. Bridge repairs, budgeted this year for \$75,000 received only one bid for \$125,000. Another \$5000 to \$10,000 will be needed for engineering. The Selectmen agreed to proceed and make up the shortfall from elsewhere in the budget (142:19 elapsed).
- **5.** Another public hearing will be scheduled on the removal of a CIP Committee member who has not been attending meetings, but refuses to resign (192:19 elapsed).

- **1.** Re-Index blanket ZO amendment. To allow the board to correct erroneous references in other sections of the ordinance via a public hearing.
- **2**. Floodplain Ordinance Amendment. Homeowners in the floodplain making improvements to their house above 50% of the market value would be required to become compliant with the floodplain ordinance. Enforcement has been difficult due to homeowners not getting permits and/or doing the work in increment over a long period of time.
- **3**. Definition of structure. Amend definition to exclude walkways & driveways. Suggestion by Chair Pat Losik to provide a list of what is a structure and not a structure in the appendix of the Zoning Ordinance. Discussion regarding differentiating impervious and pervious surfaces within the definition of structure/non structure.
- **4**. Definition of rear yard for corner lots. Currently the definition is very confusing. Attorney Michael Donovan will be drafting the amendment.
- 5. Tiny homes ordinance discussion.
- **6**. Impervious coverage. Amend the ordinance to not allow homeowners to include the beach sand and wetlands as the part of the calculation for impervious and building area coverage.
- **7**, Frontage. Attorney Michael Donovan and ZBA Chair Patty Weathersby provided language for a proposed amendment to the definition of frontage.

August 16th Site Walk

- 1. 255 Central Road: A fence is proposed, partially in wetland butter. What is now lawn would be allowed to grow. Lawn clippings will no longer be piled in the buffer and lawn equipment removed. Owner will contact Rockingham Conservation Commission regarding some phragmites observed in the buffer.
- **2**. 24 Glendale Road, A home, driveway, and septic will be rebuild in the 250' Shoreland Protection Zone with a very slight increase in impervious surface. The commission felt the new enviro septic system, pervious paver driveway, and storm water management plan would likely be an improvement over current conditions
- **3**. 1090 Old Ocean Boulevard, A seawall is proposed to be rebuilt. The commission had some concerns it extended further into the beach than the prior wall and would like confirmation it does not. Recommended 2-3 feet of native plants just behind the wall for erosion control. Approved with these conditions.

- 1. The School Budget was reviewed by School Business Administrator Amy Ransom, who has assumed full duties following the retirement of Jim Katkin. There may be some spikes in the salary line due to four retirements. Legal fees are being expended looking at the agreement with the R.J. Lister Academy for which \$75,760 is paid annually, but only one student in recent years has been enrolled and only briefly (1:05 elapsed).
- 2. Town revenues are up, but mostly because higher spending has driven up taxation. Hampton is looking at a \$45 million sewer upgrade, but Rye's share of that will be only about \$440,000 and that will likely be financed over a number of years. Any increased costs will raise sewer rates, not taxes (61:40 elapsed).
- 3. The Committee discussed the process for the upcoming budget season, including ways to increase public input, dovetailing the CIP Plan into the process, and limiting over budgeting relative to actual expenditures which ties up the taxpayers' money for at least a year before the unspent money is returned to them (160:30 elapsed).
