### **Select Board Meeting September 24th:**

- **1.** Residents of Perkins Rd. and the Jenness Beach area attended to urge resolution of parking issues and extension of the plans for controlling dogs in the Town Forest to the beach as well (2:23 elapsed). Sept 10th <u>Letter</u>
- 2. The Selectmen approved an interim ordinance establishing leash-required zones in the Town Forest (12:47 elapsed).
- 3. The Dogs-at-large Committee made three recommendations (1) tighten the definition of "dog at large" to make enforcement easier; (2) establish a "tag" program for unleashed dogs in the town forest, which would prohibit unleashed dogs unless he dog has a town-issued tag and the handler has certified that he or she has viewed a video on keeping dogs under control; and (3) provide a "leash required" period for dogs on the beach during the summer, from 7:00 p.m. to 9:00 p.m. on Saturdays (28:13 elapsed). Final Report
- **4**. The Selectmen voted to take enforcement against Ray's Seafood relating to seating capacity relative to its certificate of occupancy. Issues relating to the holding tank, operating under an expired state permit, will be addressed by the State (74:26 elapsed).
- **5**. Options for the swap shop at the Transfer Center were discussed. It has become a dumping ground for what should be trash and that is now requiring a considerable portion of an employee's time to clear out unwanted items (103:11 elapsed).
- **6**. The issue of clapboard replacement prior to Town Hall painting was discussed. It was agreed that the painting should proceed as soon as possible (173:59 elapsed).
- 7. A statement from the Town Attorney on the Verizon cell tower application 50 feet from Brackett Rd. was read justifying the continuance action with no vote and immediately upon Verizon request. Attorney Letter <u>Click Here</u>, <u>Attorney and Administrator actions</u>, letter questioning process from resident <u>Click Here</u> (122:45 elapsed).

- 2. The Selectmen discussed the 2005 road widening policy which is not being followed and has a number of other problems. Among these, the policy seems to require bike paths on all roads being reclaimed, but bike lanes should not be placed on every road, according to the Public Works Director. (55:11 elapsed)

October 4th meeting is on the Town Calendar. No Agenda is posted at this time.

- **1.** Re-Index blanket ZO amendment. To allow the board to correct erroneous references in other sections of the ordinance via a public hearing.
- 2. Floodplain Ordinance Amendment. Homeowners in the floodplain making
- improvements to their house above 50% of the market value would be required to become compliant with the floodplain ordinance. Enforcement has been difficult due to homeowners not getting permits and/or doing the work incrementally over a long period of time.
- 3. Definition of structure. Amend definition to exclude walkways & driveways.
- Suggestion by Chair Pat Losik to provide a list of what is a structure and not a structure in the appendix of the Zoning Ordinance. Discussion regarding differentiating impervious and pervious surfaces within the definition of structure/non structure.
- **4**. Definition of rear yard for corner lots. Currently the definition is very confusing. Attorney Michael Donovan will be drafting the amendment.
- 5. Tiny homes ordinance discussion.
- **6**. Impervious coverage. Amend the ordinance to not allow homeowners to include the beach sand and wetlands as the part of the calculation for impervious and building area coverage.
- **7**, Frontage. Attorney Michael Donovan and ZBA Chair Patty Weathersby provided language for a proposed amendment to the definition of frontage.

- **2.** The Chairman asked for a motion to continue the matter to December 11. The three members and the alternate present supported the motion. The motion was made and seconded, and carried without any discussion whatsoever.
- **3**. The Planning Board Chair told residents that the attorneys have everything under control and that they need to "respect the process" (40:20 elapsed).

E-mails and School minutes, Donovan 08-28-18 to BOA, Case #09 and #10-2018 Gemmet Port Herald submittal, Donovan 8-31-18 links, appraisal, Crawford Analysis

- **2.** AT&T's attorney was present to express their interest in collocating on Verizon's cell tower at 120 Brackett Rd., if it is erected (minutes, page 2)
- **3**. Town Attorney Donovan inquired as to whether there might be interest in the town-owned land at the intersection of Port Way and Holland Dr. Verizon argued that it could take up to two years to put everything in place. Attorney Donovan disagreed, saying that the Selectmen could lay out a road and the overlay district could be expanded, all by March 2019 (minutes, page 10).
- **4.** The Conservation Commission expressed opposition to the application because of the wetlands impact (minutes, page 21).
- **5.** An appraiser hired by an abutter expressed the opinion that the value of the house directly across the street from Verizon's proposed facility would be reduced in value by \$40,000 (minutes, page 21).
- **6**.. The owner of an alternate site on Brackett Rd., which would allow the facility to be located well away from the road said that Verizon acknowledged that his site was best, but said that Verizon's representative said that they had been able to negotiate a much more attractive lease with the owner of 120 Brackett Rd. (minutes, page 24)
- 7. An abutter said that Verizon has repeatedly provided misinformation (minutes, page 24)
- **8**. Another resident of Brackett Rd. said that he and another person had been able to complete test calls at 15 of 16 locations throughout northern Rye. He said that both Verizon and the town's expert had used a transmitter power of only 55 milliwatts (thousandths of a watt) to compute the coverage maps, while another document submitted by Verizon indicates a transmitter power of 120 watts (minutes, page 30).
- **9**. The possibility of Verizon being able to expand the compound in the direction of the road without seeking further approval, making it even closer than 50 feet, was discussed (minutes, page 35)
- **10.** The abutter across the street disputed that his house was not in the fall zone, saying that he personally measured the distance (minutes, page 37).
- **11**. Verizon's attorney responded that they used aerial photographs to create their drawings, refused to answer a question regarding the accuracy of that method, and said that, when their engineer is being challenged with a tape measure, things are getting out of hand (minutes, page 40).

- 1. The School Budget was reviewed by School Business Administrator Amy Ransom, who has assumed full duties following the retirement of Jim Katkin. There may be some spikes in the salary line due to four retirements. Legal fees are being expended looking at the agreement with the R.J. Lister Academy for which \$75,760 is paid annually, but only one student in recent years has been enrolled and only briefly (1:05 elapsed).
- 2. Town revenues are up, but mostly because higher spending has driven up taxation. Hampton is looking at a \$45 million sewer upgrade, but Rye's share of that will be only about \$440,000 and that will likely be financed over a number of years. Any increased costs will raise sewer rates, not taxes (61:40 elapsed).

**3.** The Committee discussed the process for the upcoming budget season, including ways to increase public input, dovetailing the CIP Plan into the process, and limiting over budgeting relative to actual expenditures which ties up the taxpayers' money for at least a year before the unspent money is returned to them (160:30 elapsed).
