

**NOTICE OF ANNUAL MEETING, NOVEMBER 27, 2018
AND SLATE OF DIRECTORS TO BE NOMINATED
RYE CIVIC LEAGUE**

The Rye Civic League will hold its annual meeting at 6:00 p.m. on November 27, 2018 at the Rye Public Library.

The Governance Committee and the Board of Directors of the Rye Civic League (“RCL”) met on October 29, 2018 to, among other topics, review the composition of the Board of Directors and their effectiveness in meeting the goals of the RCL. All of the existing Directors were willing to continue to serve as Directors. In 2017, an expansion of the Board of Directors to seven members was deemed desirable, but members who were approached respectively declined at that time. This year, the Governance Committee has successfully recruited two additional members willing to serve on the RCL board (Sarah Curtin and Kathleen McCabe).

The Governance Committee intends to nominate the following slate of individuals to serve as Directors of the Rye Civic League at its annual meeting on November 27, 2018. Other nominations may be made by any member from the floor:

Steven Borne has been President of the Rye Civic League for a number of years and has been active in various civic affairs in Rye for a number of years, as well as on the state level, including Leadership New Hampshire. He has also coached youth sports for more than a dozen seasons. He is one of the editors of the Rye Civic News and is largely responsible for gathering the content and publishing it by e-mail each month.

Peter Crawford has been Secretary of the Rye Civic League for a number of years and, in 2017, was elected to the Rye Budget Committee. Together with Mr. Borne, he is responsible for developing the annual presentation on the town and school budgets and the various warrant articles that is presented in January or February of each year. He is also one of the editors of the Rye Civic News.

Sarah Curtin is a 20 year seacoast resident, with a strong record of community service including eight years as the Chair of the Seacoast Chapter of the American Foundation for Suicide Prevention. As a mother of two young children, she is committed to promoting healthy and strong civic activity in Rye and has been a regular contributor to a variety of town initiatives forums. With over 18 years as a professional educator, she will bring a unique and valuable perspective as a board member of the RCL.

Burt Dibble is been a full member of the Rye Zoning Board of Adjustment since 2013 and a Director of the RCL for a number of years. He is not an officer of the RCL.

Alex Herlihy serves on the Rye Heritage Commission and also as an Alternate on the Demolition Review Subcommittee. For many years, and until recently, he was President of the Rye Historical Society and he continues to be very active with that organization. He was responsible for re-establishing the RCL, which had been dormant, a number of years ago, and was its President for a number of years. He is currently Vice President of the RCL. He is one of the editors of the Rye Civic News.

Kathleen McCabe has been a resident of Rye for 15 years. Over the last 12 months she has been heavily engaged with our town zoning and planning boards regarding cell tower matters. She is looking forward to expanding her involvement in town matters beyond those issues. Kathy has a Master's Degree in Health Care Administration and a Doctor of Chiropractic degree.

Sam Winebaum recently served on the Planning Board's Rules and Regulations Wetlands and Surface Water Overlay Subcommittee, formerly served on the Parsons Creek Watershed Restoration Committee, is a former member of the Rye Planning Board and has a particular interest in the Rye Master Plan. He is currently Treasurer of the RCL.

The Officers of the Rye Civic League will be elected by the Board of Directors at the first regular meeting following the Annual Meeting. The Governance Committee will recommend a slate of officers prior to that meeting.
