A. 1 & 3 Cable Road, Tax Map 5.3, Lots 43 and 44

Owner: Lawrence and Mary Tierney Alex Ross – Ross Engineering 2 lots merged together, modify existing homes, elevate and proposed new addition

The cottage will be removed the house widened and elevated with permeable pavers instead of current hard pack gravel installed. There will be a storm water management plan, Maintenance will be required as part or approvals as will native planting. Burke Pond Dam at the Abenaqui

Dam will be replaced in kind and beavers will be left alone. Members of the public commented on the need to have a "coffer" or "pillow" dam during construction so the pond does not drain and that consideration of the downstream Eel Pond needs to be taken into account.
