- 1. In response to this letter Conservation Commission says they are following the new process. Click Here for the 2017 letter. Select Board noted that all boards and committees should have a document process for appointed positions.
- 2. Public Hearing on Ordinance #22 Soliciting/Canvasing as it was pointed out that wording may not be compliant with current First Amendment interpretation. Discussion was continued to a future meeting.
- **3**. Mosquito Commission is recommending the Town continue with Dragon Fly Mosquito as they have been doing a good job and their proposal was clear and comprehensive.
- 4. Mindi Messmer provided an update on the current Cancer Cluster Commission
- **5**. Telecommunications Commission Committee and the Consultant discussed wording changes to the Cell Tower Overlay zone and the addition of land around 55 Recreation Road. Click Here for full report. The area identified is a hypothetical location.
- **6**. Consultant informed the Select Board that the town has no regulations preventing installation of broadcasting equipment to be mounted on existing poles. Select Board did not acknowledge that the risks to the town or or would take action.
- 7. Energy Committee presented and discussed the Solar Panel proposal from Revision Energy Overview for Select Board. Executive Summary, responses to questions. Proposal overviews and education is needed for the town. Energy prices, costs and future value are variables with risks that need to be understood.
- **8**. Select Board agreed to move forward and sign a agreement that if the town moved forward the Revision Energy would be the supplier as they have invested working with Rye.
- 9. Town Center committee discussed the TAP proposal. More Detail
- **10**. Warrant articles were discussed. There is posted parking signs without supporting town votes. Proposal to make some Cable Rd. Parking spaces resident only.

1. Select Board decided to move forward with putting the Exchange/Swap of the Parsonage Buildings with TD Bank building on the March 2020 ballot. The agreement has been signed and will move forward if the voters approve.

- **2.** An A-Q step process was instituted for when the Select Board purchases property, but while some steps were completed, the Select Board chose not to use the Select Board the full process for land purchases.
- **3**. Select Board stated that they will also have a warrant saying that if the swap/exchange is not approved, the Select Board can sell the Parsonage. This is not something the Town Center Committee has requested, but to avoid the costs and responsibility of maintaining an empty building.
- **4.** Residents spoke up that this action appears to be encroaching on what the Town Center Committee should be leading.
- **5**. The Parsonage uses a leach field on the RPL property and the DES will need to be involved. Town would need to grant an easement.
- **6**. Select Board and the property owner were not willing to stop the process and consider a residents suggesting that the Town buy the TD Bank building and give the owner first right of refusal to purchase the Parsonage property if the Town decides not to utilize the building.
- 7. Steven Borne requested to discuss points from his <u>Letter</u>, about no public discussion about the website, the lack of timely posted information and other points. Board asked Borne to resend the <u>Planning Communication</u> letter from November.

- 1. Kate Drago has started as the new Select Board Executive Assistant
- **2**. CMA Engineers discussed the work they would be doing to submit a TAP application for State assistance for the safety improvements.
- **3**. 1090 Washington Rd (Independence Farm) is not in compliance with some of the building requirements and action is moving to the Town Attorney.
- **4**. 487 Sagamore Rd. (European Auto) should have fewer cars parked in the front of the property, this will also be moving to the Attorney.

Conservation Commission Flood Planning November 18th: Recorded Video

- 1. Conservation Commission asked by Selectmen to consider a cell tower overlay zone on a 15 acre lot at end of Recreation Road. A letter from the Recreation Commission was read stating they are unanimously against. Note this was when placement was near the parking lot, the "hypothetical location" is now in a different area.
- 2. Trees on conservation land at a new house on Signature Drive (South Road) have been cut and continue to be cut despite a notice of violation. Consideration of charging the owners with trespassing. Signs delineating the conservation land were not in place.
- **3.** Joint Conservation, Select and Planning Board site walk to be scheduled for Verizon Port Way cell tower application.
- **4.** The CC plans to appeal a DES permit issued for 314 Brackett Road as the permit was issued before the CC could fully evaluate wetlands impact as on their first site walk the driveway was not adequately marked and the number of trees (51) to be cut in the buffer not known.
- **5**. The CC voted to acquire 0.49 acres for \$10,000 (assessed value \$37,000) off Williams Street adjacent to the Parsons Creek area marsh.

1. 2020-2025 Capital Improvement Plan was presented and accepted by the Select Board on November 25th. The Department and Districts anticipated capital expenses for the next six years total over eighteen million dollars The detailed report is available on the town's website. The tax rate is set at \$10.22. Every \$21 thousand raise the taxes 1c per \$1,000

2. Largest requests:

a) Conservation Commission: \$3M

b) Fire Department: \$1,066,000
