- **1.** Resident inquired that if there is public discussion before or after a Non-Public meeting, where and how is that being captured for the public record?
- **2.** Businesses operating on Rye Beaches will sign a Covid-Waiver, this is to protect the town from the businesses and is in addition to the current waiver.
- 3. Gyrotonic and Common Roots beach business application was approved.
- 4. Stand Up Guys (DBA Kooks Cafe) have outstanding questions.
- **5**. Summer Sessions will not have a kids summer surf camp. They will only be having rentals, group and private lessons. Application was approved.
- **6**. Chief Cotreau pointed out that the High Water Vehicle (can drive in 3ft or more of salt water) has a higher value than the old Ladder truck, so no money will be coming back to Rye.
- 7. Beach Fire Permits will be limited to six per evening and residents will be provided Covid-19 distancing information.
- 8. Chief Walsh reported about 90 parking tickets were issued last week.
- **9**. The State Parks informed Chief Walsh that Rt. 1A will remained closed for parking, but Jennes Beach, Ragged Neck (Rye Harbor), and Oridorne parking will be 100% this weekend.

- 1. Resident once more asked to discuss the Parson's Creek Pollution, Select Board refused to put the <u>2017-2019 data</u> on the screen. Since the State of NH told Rye that the Parson's Creek Watershed is over-saturated with leach fields there has not been a public discussion. More Information.

- **6**. Select Board agreed that if a residence already has beach stickers for a vehicle at that address, additional special exceptions would NOT be made. However a resident does not have a vehicle, a special exception request would be considered.
