- 1) Select Board amended <u>Click Here</u> the TD Bank/Parsonage agreement. Parsonage has been torn down and Select Board is moving forward. The Library Trustees opposed the amendment as it impedes Library expansion plans. The contract referenced in March 2020 warrant Article 7 and Select Board public statements prior to the vote said the Parsonage would not be demolished. <u>Click Here Q3</u> Residents staged a protest on November 29th at the demolished Parsonage.
- **2) The Planning Board approved** the Parsonage subdivision on November 10th and chose not to consider the entire property being impacted. NOD
- **3) Tax payments due** December 17th. <u>Click Here</u>. Town tax rate up 4%, School and County down slightly, with overall tax rate staying the same. <u>Details</u> The public document has not posted from the November 13th meeting.

- **8) WBTSCC is** looking at a 498' sea wall to protect against sea level rise. At 500' Army Corps of Engineers would need to be involved. 29,000 sq ft. permanent disturbance to wetlands requires an approximate \$50K mitigation payment to state Aquatic Fund, hopefully spent in Rye.

- 3) The majority of what Rye uses is VectoBac at \$2.00 a pound and 10 pounds are needed per acre.
