DECLARATION OF RESTRICTIVE COVENANT

KNOW ALL MEN BY THESE PRESENTS, that the TOWN OF RYE, a municipal corporation having a principal place of business at the Rye Town Hall, 10 Central Road, Town of Rye, County of Rockingham, State of New Hampshire, 03870, acting through its duly authorized Select Board, and pursuant to the Rockingham County Superior Court Order of February 16, 2021 in *David Choate, et al v. Town of Rye, et al,* hereby submits the property described by Exhibit A hereto (the "Property") to the following restrictive covenant. The Property is SITUATED IN THE TOWN OF RYE, COUNTY OF ROCKINGHAM, STATE OF NEW HAMPSHIRE.

- 1) The Property shall be used for purposes related to the Rye Public Library and shall be under the custody and management of the Trustees of the Rye Public Library (the "Trustees") so that public access and use shall be provided to any open space therein, subject to the Trustees right to reasonably regulate said public access and use.
- 2) The Property, or any portion thereof or interest therein, shall not be conveyed without a town meeting vote and the written consent of the Library Trustees. Said consent shall be recorded in the Rockingham County Registry of Deeds.
