They are an exceptionally well funded organization. Their funds for general operating expenses, unexpected disasters and overall budget is over \$8 million. We recommend not to fund them at the requested amound of \$2,500, but to fund them at \$1,500 which is in keeping with the majority of the associations we fund.

The numbers are exactly the same as last year. They served 3 Rye families and 232 regionally. They match caring mentors with at risk youth (ages 6-18). The average length of match is 3 years with a proven track record of prevention. In keeping with the other associations we fund, we recommend not funding them at the requested amount of \$3,000, but to fund them at \$1,500 which is in keeping with the majority of the associations we fund.

Center for Wildlife \$0.00 \$10,000.00 \$0.00

This organization provides a place to call with questions about wild animals or to bring in an injured wild animal. There were 59 Rye residents who brought in an injured or orphaned wild animals, as well as 199 who called seeking help identifying species in their backyard or to get information on the best lawn care for the environment. They are located in Cape Neddick, Maine, and they serve the area from Falmouth, Maine to Newburyport, Massachusetts. Our focus and mission is to help the people of Rye and the surrounding communities with the many economic and health challenges that are part of so many lives. They requested funding of \$10,000. We do not recommend using taxpayer dollars to fund this organization and request they be removed from the Request for Funding list.

This organization works to prevent or minimize trauma to victims, mostly children, 3-18 years old as a result of some form of child abuse. A healthy community is one where all residents, especially our children have access to safety in public spaces as well as safety at home. In keeping with other organizations we fund, we recommend the requested funding of \$1,500.

Cross Roads House \$ 2,500.00 \$12,000.00 \$2,500.00

This homeless shelter offers supportive services, transportation to school, long-term shelter access, visiting nurses, and it is the designated emergency shelter for Rockingham County. They have served 463 Seacoast area residents. Two individuals from Rye have stayed there for over one year for a total of \$469 bed nights at \$108 per bed night. This unfortunately is the result of the unavailability of affordable housing. We do not recommend funding this organization for the requested \$12,000, but recommend funding of \$2,500, which is above our usual funding.

Friends Program - RSVP \$ 1,500.00 \$1,500.00 \$1,500.00

The Retired Senior Volunteer Program partners with 55 non-profits and public organizations serving Rockingham County and the town of Rye. This program is Seniors helping Seniors with seniors in Rye receiving services from, Bone Builders strength training (10), Gather Food Pantry (20) AARP Tax Prep (5), just as an example. We recommend funding as requested of \$1,500.

Great Bay Services, Inc \$5,000.00 \$14,184.00 \$1,500.00

This organization is based in Dover and serves 31 individuals in the Seacoast & Southern Maine area, providing advocacy and individualized job training for individuals with intellectual and developmental disabilities. They are requesting \$14,184 to fund a new nutritional program.

We are not a grant or project funding organization. Last year they requested \$5,000 an increase from the previous year of \$1500, stating without COVID funds they'd have gone under. We recommended keeping the funding at \$1,500 as we were not responsible for keeping them afloat.

This organization is a community health center network that makes it possible for all residents in eastern Rockingham and Strafford counties to have access to primary care, pediatrics, dental care, prenatal care, behavioral health counseling, mobile health services, just to name a few. 74% of the patients they serve have a known income at or below 200% of the federal poverty level. From Jan. to July, 2023 they served 75 Rye residens. We recommend the requested funding of \$2,000.

This organization is very well funded, with Federal and State grants alone of over \$1.7M. They did not indicate how many they served in Rye or the surrounding area. Although they provide much needed support for violence prevention and improvement in the well-being of children, they received one of the highest donations. It is our recommendation that we reduce the funding from \$3,250 to \$2,000 keeping them in line with similar donations.

Home Health VNA of NH \$ 9,975.00 \$0.00 \$0.00

Was formally known as Seacoast VNA, but are now Home Health VNA of NH, that is part of Home Health Foundation and all of which are under Tufts Home Medical Care at Home, a large Massachusetts based organization. They notified Janice in September that a transformer blew in their building, and they were unable to access their computers. As of our meeting on Sept. 27, no information has been submitted. This organization requested the largest amount last year and our recommendation was not to fund them as the EIN number they submitted belongs to Tufts. We recommend they be removed from the Request for Funding list.

The Center is run out of a couple's home, questioning why we would donate money when we have no information on how donations have been used in the past and wll be used in the future. Even with the lack of information, we do not support using taxpayer dollars to support a wildlife organization as they do not meet our focus and mission of helping the people of Rye and the surrounding communities. We request they be removed from the Request for Funding list.

Although this is a worthy organization, they are part of N.H. Catholic Charities and they also provide services through New Frontier Church. We feel we should not be supporting religious organizations in keeping with the separation of church and state and in fairness to all denominations. N.H.S.P.C.A \$ 1,000.00 \$1,000.00

This is excellent and reliable organization, providing care, and shelter for domestic animals and pets. 123 Rye residents were served. They are a strong asset to the rural, farming community. They provide low cost rabies and spay/neuter clinics and have a highly regarded and affordable pet behavior training, animal cruelty intervention, pet loss support group and Alzheimer's Cafe's. We recommend the requested amount of \$1,000.

Their dedicated focus is on the well-being of children and families by providing essential social services that strengthen family life. They served 18 Rye families and 701 families in the Seacoast area. We recommend funding this organization for the requested amount of \$4,800.
