Article 6: Harbor Rd. Bridge replacement \$975,000

After much investigation and engineering work the town has agreed on a plan. There was a trade-off for how long there would be no access for residents and cost.

Funding an identified Capital Project is one of the acceptable uses of the unassigned fund balance. This is money the town currently has that will be used to fund this project.

Yes: Town will move \$975,000 to the DWP for replacing the bridge

No: Will prevent the town from using this money for the bridge work.

Article 7: Use \$307,000 towards replacing the Perkins Rd. Culvert

Funds will be moved from the unassigned fund balance to DPW for this work. The town currently has these funds, so this will not directly raise taxes.

Yes: Use \$307,000 from the Unassigned Fund balance to pay for the Culvert

No: Do not use the Unassigned fund balance for this culvert replacement

Article 8 DPW Highway Equipment Capital Reserves (\$200K)**DPW:**

- Shift in strategy. Not holding on to vehicles to the end of life as there is no re-sale value. Replacing sooner may help reduce the overall costs to the town.
- Historically this had been \$100K per year and is expected to ramp down to this amount
- ~ **\$1.7M** of DPW trucks/equipment used for the transfer station and road maintenance. Lifetimes vary. Rolling
- Rolling replacement rotates out the oldest equipment as maintenance costs and inconveniences increase; and smooths taxes with contributions each tax year to this capital equipment reserve.
- DPW staff plans on purchasing one vehicle a year, each purchase consumes a fair amount of DPW time and effort, so multiple purchases in a year should be avoided

Current Fund Balance: \$77,486

Yes: Add \$200K to the reserve fund to support the rolling replacement plan. Keep tax rate steady despite periodic large ticket items purchased

No: Leave the reserve fund balance as is with no additional funds this year.

Article 9: \$160K towards the Library Common upgrade

Total project will be over \$500K. The balance of the funds will be from Rye Library funds and additional fund raising.

Yes: Provide \$160K for the Library Common work.

No: Do not contribute \$160K raised through taxes

From RPL:

Features of the design include a performance space (i.e., a gazebo/bandstand), smaller seating areas for informal gatherings, book clubs and smaller Library events, a larger patio, gardens using native plants and new hardwood trees. The goal is to create an iconic Town Center which will act as a magnet to bring people together. The Trustees are excited to share specific design elements with the public in the near future as we continue reviewing options.

Initial estimates indicate that the Library Common project will cost approximately \$500,000. The Trustees seek \$160,000 in public funding to assist with this effort, with privately raised funds making up the remainder of funding for the project. We believe that the result will be a space that the people of Rye will enjoy for generations.

Article 10: Fire and Ambulance Capital Reserve fund**Fire & Ambulance:**

- Request \$100K for this year
- The separate Ambulance & Fire Vehicle Fund is funded through Grove Rd. Cell Tower at \$50K a year now goes into this fund.

Current Balance of Fund: **\$403,704 (as of 10/31/22) \$370K coming out for the new Ambulance**

Yes: Add \$100K to the reserve fund to support future equipment purchases

No: Leave the reserve fund balance as is with no additional funds this year

Article 11 \$75K to create a Softball Field at Rye Recreation

Rye Softball has grown to approximately 90 players and the single field at the Rye Elementary School can't accommodate all of the teams for practices and games.

Plan is to convert a corner of the Recreation Field for Spring softball, leaving the space available for Fall Soccer. [Click Here](#) for Image

Yes: Provides funds to create a second Softball Field

No: Town can't spend funds to support this effort this year. Does not preclude Rye Softball from funding the effort.



Article 12 \$75K for Design and Engineering of new buildings

Funds are coming from the Recreation Youth Athletics Fund. These are fees accumulated from Rye Recreation Activity account. This is the revolving fund that for the Athletic Programs. This does not impact taxes as the funds are currently available.

The Recreation Master Plan is a Recreation Facility Plan and not a Master Plan for Rye's Recreation Needs. [Click Here](#) for full size image.

Yes: Allows Recreation to contract for this work

No: Town can't spend funds to support this effort this year. Money could be raised privately.



Article 13: \$35,000 for Municipal Buildings Maintenance Fund

Current Balance: **\$203,620 (as of 10/31/23)**

Select Board discussed projects that will extract funds from this account.
Fund is used for major repairs to municipal buildings

The similarly named Municipal Building Construction and Renovation Fund with **\$104,580** (as of 10/31/23) is used for construction and renovation.

Yes: Add \$35K to the maintenance fund

No: Leave the fund balance as is with no additional funds this year

Municipal Separate Storm Sewer System (MS4)

MS4 is a publicly-owned storm drain, pipe, ditch, or other means of collecting and transporting rain water (i.e. stormwater) from a town to an outfall that deposits the water into a stream or river.

Article 14: Fund for MS4 and Spill Prevention \$25K

SPCCP = Spill Prevention Control and Countermeasure Pland

SWPPP = Storm Water Pollution Prevention Plan

MS4 = Municipal Separate Sewer Stormwater System

Establishes a fund for unanticipated costs during the year.

Yes: Agree with having a reserve for major unplanned and required actions

No: Find or reallocate funds for current budgets

Article 18: Rye Public Library Building Maintenance Fund: \$10,000

Current Balance: **\$35,433 as of 10/31/2023**

Fund created in 2005 as a maintenance fund for Library.

Yes: Add the requested funds to each account to accrue funds over time

No: Do not add the requested funds to each account

Article 15: Rye Public Library HVAC Fund \$20,000

Current Balance: **\$80,012 (as of 10/31/23)**

Time is now so this gets us to what it may cost.

Yes: Add the requested funds to each account to accrue funds over time

No: Do not add the requested funds to each account

Article 16: Create a new fund to be used for un-expected expenses

Today, if there is an un-planned expense, the money needs to come from another named budget account. Normally the “best fit” is used. There may not be a good match.

\$15K will be pulled from the “Un-assigned Fund Balance” and held in this account each year. If it is not used, it will be returned to the “un-assigned fund balance”

Yes: Make it easier for the Select Board to react and spend to address emergencies

No: Would require funds to come from other planned accounts. Would enable more funds to be used to pay down annual taxes.

.

Article 17: Revaluation Capital Reserve Fund \$15,000

Fund was established in 2020 to fund revaluation. State law requires property revaluation at a minimum every five years.

Total cost is estimated to be \$75,000.

Balance as of 10/31/2023 was: \$16,000

Yes: Add \$15k to the fund Reduced the 5th year cost of funding the re-evaluation.

No: Leave the fund balance as is with no additional funds this year

Article 19: Annually have a fund to be used for Emergencies

The RWD Boil Water alert required funds for some actions, like buying water. There was not a specific place for those expenditures to come from. [RSA 35-1](#)

\$10K will be pulled from the “Un-assigned Fund Balance” and held in this account each year. If it is not used, it will be returned to the “un-assigned fund balance”

Yes: Make it easier for the Select Board to react and spend to address emergencies

No: Would require funds to come from other planned accounts. Would enable more funds to be used to pay down annual taxes.

.

Article 20 Conservation Maintenance Expendable Trust \$10,000

Current Balance in the fund is: \$38,655 as of 10/31/23

Yes: Add to this fund that was created in 2021 for maintain Goss Farm and conservation land.

No: Do not make an annual contribution to this fund, leaving the current balance as is.

Article 21: Recreation Building Reserve Fund \$10K

Current Balance is: \$15,952 as of 10/31/23

This is a name change from Capital Reserve to Buildings and Maintenance so that funds can be used for both.

Recreation Master Plan update is in process.

Yes: Add \$10K to the building maintenance fund

No: Leave the fund balance as is with no additional funds this year

Article 22: Change the Grove Road Landfill to Landfill Monitoring

This is so the funds can be used at Breakfast Hill Landfill. Grove Rd. is a Dump not a Landfill.

Article 23: Now called the Landfill Capital Reserve \$10K

Current Balance is: \$7,870 as of 10/31/23

Annual Cost estimates are: Not disclosed

As this is something that must happen every year, after this year, this cost should move to operating expenses.

Fund covers the cost of the monitoring and testing of the samples for PFOA.

This is the old Rye Town Dump. When Testing for PFOA started, readings in the harmful range were recorded around the landfill.

This dump and the current Transfer Station are uphill from the Garland well. The soil here is transmissive (i.e., pollutants are less abated as they make their way toward our drinking water)

Yes: Add \$3K to the fund to maintain the testing and monitoring

No: Leave the fund balance as is with no additional funds this year

Article24: Center for Wildlife \$2,500

Historically a warrant article would add an entity to the Regional Association budget for the Town to make a contribution to. Once on the list it would either continue or groups with “fund raising” staff would push and get an increase from Rye.

The Select Board created a new Committee to review and use this process [Click Here](#) to evaluate the current list and make recommendations. [Click Here](#)

Committee reduced this budget by about \$20K from previous years as many agencies no longer met the established criteria.

The Center for Wildlife did not provide the requested information and was not recommended for this list. Select Board Member McGrath has served as the Rye Animal Control Officer and knows firsthand the Services Rye receives. This is his recommended contribution amount.

Yes: Add \$2,500 to the Regional Association budget for the Center for Wildlife

No: Rye will not be able to make a contribution to the Center for Wildlife

Article 25: End the Rye 400 Fund

Yes: Moves any balance to the general fund

No: Leave the fund balance as is.

Article 26: End the Parsonage Maintenance Fund

Yes: Moves any balance to the general fund

No: Leave the fund balance as is.

Article 27: Treasurer to be appointed rather than elected

The Treasurer is responsible for all of the financial assets of the town except those under the jurisdiction of the Trustees of the Trust Funds and those special funds that are managed by other Town officers as prescribed by law. The Treasurer signs all Town payroll and Accounts Payable checks; has the authority (along with the Select Board) to borrow on behalf of the Town; maintains all of the Town's bank accounts; and reconciles the Town's bank statements. The Treasurer also holds the Town's escrow and other cash accounts.

Select Board wants to do the "hiring" and not let the voters decide who has the skills to manage the finances. Becomes a concern of how aggressively or conservative you want to manage current account balances.

Yes: The Select Board would hire the next Treasurer.

No: Town would continue to elect this position

Article 28: This would make the Tax Collector an appointment to the Select Board

Currently we Elect the Town Clerk/Tax collector who hires the assistant Town Clerk/Tax Collector. There is also a part time person.

This would leave the Town Clerk only doing the Town Clerk functions.

This has to happen in two steps.

- 1) Town has to say NOT to continue the dual Clerk/Tax Collector
- 2) Then the next warrant article empowers the Select Board to hire the next Town Clerk

What are the problems that are being addressed by making this change?

Why is this better for the town?

What are the long term cost impacts of this?

Yes: This will keep things as they are. Dual Clerk/Tax Collector

No: Would split this to two positions with the Tax Collector under the Select Board

Article 29: Allows Select Board to “hire” the Tax Collector

This article is only relevant if Article 28 is voted down. So a NO vote is the majority.

A yes, then allows the Select Board to hire the Tax Collector.

Yes: If Article 28 does NOT pass, then this also needs to pass to change the position to appointed.

No: If article 28 passes than this article is mute.

If Article 28 fails and this also fails?

Good question.

Article 30: Petitioned Warrant Article – Change Speed Limits

[Click here](#) for petition.

ARTICLE 30. (By Petition) Shall the Town of Rye reduce the speed limit from 35 mph to 30 mph on all town roads where the current speed limit is 35 mph, effective June 1, 2024.

State Law says that:

Rural Zones are 35mph

Urban Zones are 30mph

Article 33: Petitioned Warrant Article – Building Permit Process

To see if the Town will vote to appropriate human and technical resources needed to document all procedures for obtaining a building permit. Documentation shall include, but is not limited to, how commissions such as RCC (Rye Conservation Commission) and DRC (Demolition Review Committee) are to be engaged, by whom and when. Documentation shall also specify the legal limitations on the RCC, DRC and any other appointed (un-elected) committees in terms of their recommendations.

Procedures will also address zoning and planning variances, including: how an applicant can be adequately prepared for presentation to said committees, the limitations on committees revisiting previously determined elements of a submission and expectations on how long a decision will take as well as any costs that may be incurred.

These procedures will include a schedule of fees and expected expenses, as well as reasonable expectations for how long each step of the process will take. This information will enable applicants to better plan and prepare a budget for their building maintenance and improvement projects and in so doing use the time of the ZBA (Zoning Board of Adjustment) and PB (Planning Board) more efficiently in service of the Town of Rye and the applicants.


