In addition to the minutes, manifests, and any transfers, you will vote on the figure you wish to retain from the end of year fund balance and how much you expect to return to the town. This will include affirming the actual dollar amount for the playground contribution. You will also be asked to vote on the Food Service Contract Proposal (see notes below). I will also ask you, as is typically done each June, to give me the authority to offer contracts to fill any current or new openings we may have in the summer as you will not meet again until August. Lastly, you have two policies to approve for first reading and one to approve/reaffirm in a single reading (notes below).

Proposed Policies

Policy EBCC and JH are presented for first reading. EBCC is updated by the NHSBA to reflect a variety of threats schools could face (previously just bomb threats). Policy JH is brought at the request of the administration. Our current policy does not place enough of a limitation on what is considered an "excused" absence and we need to have a policy that can better help us in cases of extreme absenteeism or truancy.

Policy DFA is coming to you at the request of Sue Penny to simply reaffirm in a single reading so we can keep a current date on the policy for auditing purposes.




Food Service Proposal
